Upon approval of your Lobird® account we will use the information provided here, specifically Primary Contact Name and e-mail, to set-up an account in our wholesale shop that you will utilize when ordering Lobird® stationery at lobird.com/wholesale.

Lobird® is required by law to have on hand your Tax Id, Resale number, a copy of your reseller's license and a signed Resale Certificate. Once you have completed the Dealer Application in this document please forward it along with the signed resale certificate (last page of this document) AND a copy of your resellers license to Lobird. Please note that Lobird has a \$150 minimum purchase amount and we require a credit card payment at the time of your order.
